ADMINISTRATION FEE (non refundable) \$80.00 per family

SCHOOL DAY PROGRAM

Applies to days that school is in session, including minimum days, full service days and those public holidays that the Center is closed. The Center is normally open Monday through Friday. Families receive a 10% discount for a second child in the program, and a 15% discount for each additional child. The discounts are applied to the child with the lowest tuition rate.

Full tuition is expected for weeks that include the 11 regularly announced CDC holidays: Independence Day, Labor Day, Thanksgiving Day (2), Winter Holiday (2), New Year's Day, Martin Luther King Jr. Day, Presidents Day, Memorial Day, one additional holiday, and one additional day for staff in-service/training. The Center is also closed two days at noon, which will be announced in advance.

Basic Plan Includes regular school days, minimum days, early dismissal days, and full service days.
All Inclusive Plan Includes Basic Plan plus Winter Camp, Presidents Recess, Spring Camp, and the entire month of June.

**Tuition Policies
2011 - 2012 School Year**

- Tuition schedule is based on:
 - Basic: 9 payments during the school year and 1 payment for June.
 - All Inclusive: 10 payments during the school year and June.
- Families may choose between two tuition Plans (Basic or All Inclusive). Changes in Plans for the school year are not allowed, except within the first 30 days of enrollment. A \$25 administration fee will be assessed for this **one** time change.
 - Basic Plan** includes regular school days, early dismissal days, minimum days and full service days (District holidays, teacher/student conference days, days before and after school begins and ends to complete the week).
 - All Inclusive Plan** includes the Basic Plan plus Winter Camp, Presidents Recess, Spring Camp, and the days after school ends through the end of the month of June.
- **Two** changes (increase/decrease in hours or days) within your chosen Plan are permissible within the school year. A \$25 administration fee will be charged per change. Changes **must be in writing at least two weeks** in advance, on the Termination/Change form provided to you by the Site Supervisor. Changes must be made prior to the 15th calendar day of each month, to be effective for the following month.
- Tuition payments are due on the following listed dates:

September 1, 2011	February 1, 2012
October 3, 2011	March 1, 2012
November 1, 2011	April 2, 2012
December 1, 2011	May 1, 2012
January 2, 2012	June 1, 2012
- Tuition is due on the first day of each month and considered late on the 10th day of the month. The center is not responsible for billing. A late fee of \$25 will be assessed on the 10th day of the month. Tuition payment that is ten (10) days late may result in suspension or termination. Balances that remain unpaid after fifteen (15) days may be referred to a collection agency for payment and you will be responsible for any collection costs.
- CDC expects one payment at each due date. If two payments are necessary, the 2nd payment is due on the 15th calendar day of each month. There will be an extra \$5 administration fee due with the second payment. A late fee will be assessed on the 17th calendar day, if payment is not received for the 2nd payment. Prior arrangements need to be made, in writing, with the Site Supervisor.
- Withdrawal of your child from the program requires a two (2) week written notice in advance of withdrawal date. Tuition must be paid in full through the approved withdrawal date, whether your child attends or not. A refund will be given for any overpayment of fees. Allow 2-3 weeks for refund to be processed.
- Late pickup fees of \$15.00 will be assessed for any part of a fifteen-minute increment, if a parent is late in picking up their child after a program ends. Three (3) late pick ups during a fiscal year may result in termination.
- Drop-in rates apply to any care outside of your Tuition Enrollment Plan. Drop-in rates can not be used on a consistent basis. Prior arrangements need to be made with the Site Supervisor and care is based upon center availability. Families must complete required emergency information and pay the following fees.
